INTRODUCTION

Thank you for considering Mindscape Education's products and services; Mindscape's offerings are aligned with requirements of the National Curriculum and Assessment Policy Statement (CAPS).

Services offered are limited to Mindscape's products and services to learners being home educated in Grade R to 9 and Distance Education learners in Grades 10 to 12 (FET Phase) and does not include tuition or facilitation.

Mindscape Education is registered with the SACAI and IEB assessment bodies for the National Senior Certificate (NSC).

Mindscape Education is neither a public nor independent school and does not register learners, with the Department of Education in terms of Section 51 of the South African Schools Act no. 84 of 1996. The parent/guardian is responsible for registration with their local Provincial Education Department.

Examination body fees for GR12 are invoiced separately from the curriculum fees above and are payable in full to enrol GR12 candidates for the **2026 NSC** exam.

* Examination fees Grade 12:

- Grade 12 exam fees levied by the examining body is NOT included in the annual fee above.
- To facilitate registration with examination bodies timeously, all registration fees are to be paid in full to Mindscape Education before 28 February 2024, Non-payment and/or late payment of fees will result in non-registration for the National Senior Examination.

** Examination Body Learner Placement Fee Grade 12 (LPF)

- The Learner Placement Fee (LPF) is NOT included in the fees and is payable in full by 31 May 2026 to ensure placement of learners at a exam venue, where the learner will write the final NSC examination.
- Concession learners may incur additional costs; based on the nature of the concession, concession fees are payable directly to the NSC exam venue.



PAYMENT DATES:

Registration Fees are payable in full, upfront on approval of enrolment by EFT.

Monthly payments via Debit Order only in 10 x monthly instalments from January to October 2026.
